### Job Overview - Description & Duties

For over 45 years, The Ken Brown Recovery Home (KBRH), a not for profit charitable organization, has provided Residential Addiction treatment services in a supportive housing environment, to men 16 years of age and older who suffer from Substance Use Disorder.

The KBRH is seeking to engage an individual for a 1 year of a possible, multi-year internship contract in a Resident Attendant/Counsellor in training position, providing hands-on and academic training hours to the intern, for eventual professional certification as a Canadian Certified Addictions Counselor (CCAC).

Duties: Under the supervision of the Executive Director (intern supervisor) the intern will:

Academics: Be supported by, and begin taking the required academic courses specific for certification through the CACCF.

Supervised clinical training: Work directly with the Executive Director to:

Resident Attendant training:

- Be trained in and execute all duties of the Resident Attendant position
- Consult with supervisor as required
- Other duties as assigned by the supervisor

Counsellor training:

- Coordinate the admission and intake of new clients
- Model the supervisor in providing counselling regarding the use and effects of all mood-altering substances
- Model and support health and wellness activities and healthy coping skills for residents
- With supervision, facilitate individual counselling sessions with residents
- Assist ED with facilitation of group therapy sessions
- Maintain strict confidentiality of clients
- Consult with supervisor as required
- Other duties as assigned by the supervisor

Hours of Work: Shift work with a minimum of 40 hrs/week-Days/ Evenings, Night-shifts &/or weekends & holidays.

### Required Skills

Applications will be accepted from & successful candidates for this internship, will meet most/or all of the following educational, skills/competencies & qualifications:

- Is a new entrant into the addictions field, and/or is transitioning to a new career.
- Graduate of a post-secondary College or University with a specialization in addictions, psychology, social work, business/arts or human services, or
- Registered in and/or in the process of, completing an online and/or in-class College diploma or University degree program in addictions, psychology, social work, or human services.
- Has a Valid drivers license.

- Previous work experience in an addictions setting (short-term 30-day intensive treatment centre program, medium to long-term 90-day residential treatment facility (i.e. Recovery Home), residential withdrawal management, etc.)
- Is a member of, or has lived experience, in dealing with the most vulnerable of society, and/or minority or diverse populations (individuals or groups of people who represent the homeless, substance use disorder and/or mental health individuals/groups, Indigenous, LGBTQS2+, & BIPOC communities)
