### **Job Overview - Description & Duties**

TITLE: Community Outreach Coordinator

POSITION STATUS: Full-Time, 1 year contract with potential to renew

LOCATION: Operations based in Sault Ste. Marie with hybrid option. Travel required.

PRIMARY FUNCTION: Working under the supervision of the Waa-Naadmaaged (Shingwauk Site Search Coordinator), the community facilitators will support engagement with 85 Indigenous communities from which children were forced to attend Shingwauk Residential Schools, as well as Knowledge Keepers and Elders as appropriate. Engagement will focus on the development and implementation of cultural and communications protocols that will guide the search, fieldwork and commemorative activities undertaken by CSAA and its partners. Approximately 50% of staff time will be spent in First Nation communities.

## Responsibilities to include:

- Supervision of Community Outreach Facilitators, including work plan development and monitoring
- Coordinate coverage for absences, holidays and other gaps
- Share information on the Shingwauk Site Search with identified First Nation communities
- Assist in convening both online and face-to-face meetings with First Nation communities
- Maintain and coordinate schedules for presentations and communications
- Assist in soliciting feedback from stakeholders and partners
- Assist in organizing events and gatherings, including promotion and execution
- Liaise with other team members for event & presentation coordination

### **Required Skills**

- Demonstrated, strong written and oral communication skills
- Demonstrated, strong sense of empathy
- Ability to organize and work independently and as a team player
- Demonstrated lived experience with Indigenous communities and survivors of residential school and their intergenerational impacts

- Previous training with trauma-informed care & practices
